

**City of Cody
Council Proceedings
Tuesday, March 7, 2023**

At 6:45 p.m. Council Member Reiter made a motion seconded by Council Member Shreve to enter into an Executive Session Pursuant to Wyoming State Statute 16-4-405(a)(vii). At 7:00 p.m. Council Member Swett made a motion seconded by Council Member Reiter to exit the Executive Session. No Action was taken.

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, March 7, 2023 at 7:00 p.m.

Mayor Hall called the meeting to order at 7:02 p.m.

Council Member Swett made a motion seconded by Council Member Tamblyn to approve the Consent Calendar as presented including approval of Minutes February 21, 2023, Special Work Session from February 28, 2023, approve Vouchers and payroll in the amount of \$502,046.28, and authorize the Mayor and City Attorney to sign and approve the transfer of AIP Fund from YRA to the City of Newcastle and County of Weston (Mondell Field) and City of Torrington (Torrington Municipal Airport), noting these funds were transferred to YRA in previous calendar year. Vote was unanimous.

Council Member Quick made a motion seconded by Council Member Fritz to approve the preliminary plat of the Case Minor Subdivision, a 3-lot subdivision, with associated variances and conditions of approval. Vote was unanimous.

Council Member Reiter made a motion seconded by Council Member Swett to approve the final plat and construction plans for the SunRidge Subdivision, a 5-lot subdivision, subject to conditions of approval. Vote was unanimous.
